1. This Multiple Bank Accounts Registration Form allows investors to register multiple bank account details for investments held across all folios in schemes of Baroda Mutual Fund (for existing investors) or when making an investment in any scheme of Baroda Mutual Fund (for new investors).
2. With a view to preventing fraudulent transactions, investors are encouraged to register multiple bank accounts and make payment for their purchase transactions in the schemes of Baroda Mutual Fund only through such accounts or such other bank accounts as may be registered from time to time.

Individuals and HUF can register upto 5 different bank accounts. Non-individuals can register upto 10 different bank accounts, including a default bank account, across their folio with Baroda Mutual Fund.
2. For existing unit holders who have multiple folios with Baroda Mutual Fund, please mention all such Folio numbers separated by commas.	2. Bank account details as filled in the Registration form does not matches with the Cheque leaf, the request will be rejected. Applications not accompanied by a cancelled cheque leaf / copy of cheque leaf will also be rejected.
