## INSTRUCTIONS FOR NOMINATION

- Nomination can be made for maximum number of three nominees. In case of multiple nominees, the percentage of allocation/share in favour of each of
  the nominees should be indicated against their name and such allocation/share should be in whole numbers without any decimals making a total of
  100 percent. In the event of the unit holders not indicating the percentage of allocation/share for each of the nominees, Union Mutual Fund/ Union
  Asset Management Company Pvt. Ltd. (AMC) by invoking default option shall settle the claim equally amongst all the nominees.
- 2. Nomination can be made only by individual's applying for / holding units on their own behalf singly or jointly. Non-individuals including Society, Trust, Body Corporate, Partnership Firm, Karta of Hindu Undivided Family, Holder of Power of Attorney cannot nominate.
- 3. Nomination would be registered at the folio level and shall be applicable for investments in all schemes in that folio.
- 4. Where a folio has joint holders, all joint holders should sign the request for nomination/cancellation of nomination, even if the mode of holding is not "joint".
- 5. Nomination form cannot be signed by Power of Attorney (PoA) holders.
- 6. Every new nomination for a folio will over written with the existing nomination.
- 7. Nomination shall be mandatory for new folios opened by individuals specially with sole holding and no new folios for individuals in single holding will be opened without nomination. Those investors who do not wish to nominate must confirm their non-intention to nominate.
- 8. Nomination will not be allowed in a folio held on behalf of a minor.
- 9. A minor can be nominated and in that event, the name and address of the guardian of the minor nominee(s) shall be provided by the unit holder. However, in such cases, the unit holder(s) cannot be the guardian of the nominated minor(s). Nomination can also be in favour of the Central Government, State Government and a local authority, any person designated by virtue of his office or a religious or charitable trust.
- 10. The Nominee shall not be a trust (other than a religious or charitable trust), society, body corporate, partnership firm, Karta of Hindu Undivided Family or a Power of Attorney holder.
- 11. A Non-Resident Indian can be a Nominee subject to the exchange control regulations in force, from time to time.
- 12. Cancellation of nominee can be made only by the individual(s) who hold units on their own behalf singly or jointly and who made the original nomination. On cancellation of the nomination, the nomination shall stand rescinded and the AMC shall not be under any obligation to transfer the units in favour of the Nominee.
- 13. Nomination in respect of the units stands rescinded upon the redemption of units.
- 14. The rights in the units will vest in the nominee(s) only upon the death of all unit holders.
- 15. Transfer of units in favour of nominee(s) shall be valid discharge by the AMC against the legal heir.
