**INSTRUCTIONS CUM TERMS AND CONDITIONS**

- Investor can have an option to Pause his SIP temporarily for specific number of installments. i.e. Minimum 1 installment and Maximum 6 installments. SIP would restart upon completion of the period specified by Investor.
- Investor can opt for pause facility only once during the tenure of particular SIP.
- If the SIP pause period is coinciding with the Top-Up facility, the SIP installment amount post completion of pause period would be inclusive of SIP Top-up amount. For e.g. SIP installment amount prior to Pause period is INR 3,000/- and Top-up amount is INR 1,000/-. If the pause period is completed after date of Top-up, then the SIP installment amount post completion of pause period shall be INR 4,000/-.
- The minimum gap between the pause request and next SIP installment date should be atleast 15 calendar days (excluding the request date and the next SIP installment date).
- Pause facility shall get activated from immediate next eligible installment from the date of receipt of SIP Pause request. Investor cannot cancel the SIP Pause once registered.
- The SIP shall restart from the immediate trigger date after the completion of the Pause period.
- SIP Pause facility will not be available for the SIPs sourced/registered through MFU, Exchange & Channel platforms as the mandate is registered by them or for SIPs which are registered as standing instructions with their banks.
- Investors need to provide all the required information such as folio number / scheme / plan / SIP cycle date / SIP Amount etc., in this SIP Pause form.
- The AMC reserves the right to terminate this facility or modify the conditions of the SIP Pause facility at its discretion.
